You have demonstrated experience in providing excellent customer service skills and excel at embracing diversity while establishing rapport with clients. Your preferred post-secondary education in Business or Social Sciences or Skilled Trade is complemented with related experience. Ideally, you have office experience and proficient in using Microsoft Office Products.

Under the direction of the Executive Director and supervised by the Operations Manager, the incumbent will provide operational support as well as be assigned specific responsibility related to the organizations' vision, mission, values, and strategic plan that will serve the First Nation citizens of the AETS nine member participating communities. The role includes but not limited to, working with staff, committees, stakeholders, participants, potential participants to:

- Support the co-ordination and implementation of three Pre-Apprenticeship Training Program (PATP)

  General Carpentry programs with other related trades
- Recommend and help integrate marketing strategies to effectively promote the requirements of the Pre-apprenticeship Training Program to secure ideal candidates
- Participate in strengthening recruitment, screening, selection and orientation of program participants, training providers and employer community projects
- Implement outreach strategies for participants to foster success in the program
- Monitor program budgets and participants throughout the duration of program, as well as completes compliance and other required program reports and/or proposals
- Works as a liaison between AETS and delivery partners, including but not exclusive to employers for subsidized work experiences to ensure delivery requirements are fulfilled
- Assist in planning and delivery of Graduation program for participants
- Other duties as required

**Qualifications:** Post-Secondary Diploma/Degree in Business or Social Science related discipline or Skilled Trade. Experience in service delivery of labour market programs including trades; or a combination of education & training with minimum of 3 years related work experience in labour market program delivery.
