17 YEARS OF AGE +

- Self identify as Indigenous with affiliation preference to AETS Member First Nations
- Grade 10 Math Requirement
- **Pre-assessment Activities:** Applicants should be prepared to explain, why they are interested in a career in mining as well as complete an application process. Applicants must participate in an assessment and interview covering the following topics to manage barriers for success: Housing, Training Location, Health, Travel, Funding, Education, Language, Environment.

- Applicant Interviews with AETS Team Member(s).
- Complete the requirements of a drug/alcohol test as well as a criminal background check; due to the underground nature of this training and for reasons of safety. **Provided to you.**
- Driver's license is preferred, or must have a willingness to secure a license

NOTE: Cohort 1: can continue after Mining Essentials extended training to the Construction Craft Worker/Cement Finisher starting Sept. 5 2023. Cohort 2: can start with Heavy Duty Equipment Technician on June 19, 2023 prior to starting Mining Essentials on Sept. 18, 2023.

Background



The Assembly of First Nations (AFN) and the Mining Industry Human Resources Council (MiHR) partnered to develop the Mining Essentials Training Program. The goal of the national work-readiness training, is to provide Indigenous Peoples with the skills and confidence needed to enter the mining workforce, and in turn, to provide industry with a ready-to-work, local workforce, based on a nationally validated pre-employment program.

Program Description



AETS in co-operation with Confederation College will provide common core competency training. Accommodations and training/meal allowances are provided for up to 15 participants. The culturally aware and responsive program includes classroom and work enrichment, as well as common core training. Academic upgrading assistance is available.

- **Cohort 2: Oct. 2 to Jan. 12** (13 weeks) followed by Subsidized Work Placement in Mining Sector
